SLT.House - Disciples Den Agreement

Basic Rules and Guidelines:

1. I will treat others with respect in manners of actions and words.
2. I will respect the privacy and property of others.
3. I will not create loud disturbances of any kind, and will be quiet after 11pm.
4. I will not use anyone's phone, food, clothing, cars, bicycles, or other personal belongings without consent / permission.
5. I will have permission before entering another resident's bedroom.
6. Guns, knives, archery equipment and all other weapons are prohibited. Pocket knives with blades less than three inches and cutlery for food prep are allowed.
7. Gambling is prohibited. Borrowing or loaning money to residents is prohibited.
8. No pets are allowed.
9. Smoking in the house is prohibited.
10. Illegal drugs and alcohol of any kind is not allowed.
11. Entering the premises while under the influence of alcohol or drugs is prohibited.
12. Criminal activity of any kind is not allowed.
13. Pornography of any kind is not allowed.
14. Changing the oil in one's car on the property is prohibited.
15. Parking on the lawn is prohibited.
16. Nailing, taping, gluing, etc... to wall or fixtures is not allowed (unless approved by staff).
17. No female visitors are allowed (except for family, wife, daughter, mother, etc...).
18. Computers are allowed only if the password is known by the Director.
19. I will assist with maintenance of SLT.House by performing daily and weekly chores as assigned (lawn mowing, snow shoveling, raking, housework, etc...).

Other Duties and Responsibilities:

1. I will attend the in-house weekly Bible study and meet with my assigned mentor weekly.
2. I will attend at least one weekly Christian based recovery meeting (AA and NA are acceptable).
3. I will regularly attend at least one weekly church service at a Bible believing Christian church, and provide proof of attendance to the Director.
4. I will attend the in-house weekly skills class, and agree to have a workable budget set up.
5. I will keep the house clean, make bed daily and do all other chores as assigned.
6. I will report my work schedule to the Director and report any changes immediately.
7. I understand these terms are not all inclusive and it is my responsibility to keep track of any and all amendments to this agreement.
8. I UNDERSTAND THAT I AM NOT RENTING A ROOM, SPACE, OR ANY PART OF THE PROPERTY OR HOUSE. I UNDERSTAND AND AGREE THAT VIOLATING ANY TENETS OF THIS AGREEMENT MAY SUBJECT ME TO IMMEDIATE REMOVAL FROM THE PREMISES.

Cost and Budget:

1. I agree to pay a weekly fee of \$65.00 to \$75.00 per week (depending on room size).
2. I agree that my workable budget will include provision for tithing and savings.
3. I will not have any monthly obligation that may be linked to this permanent address (telephone, cable, internet, satellite, etc...).
4. I will not make any monthly financial obligations (car purchase, monthly cell phone plan, etc...) without first consulting the Director.

SLT.House - Disciples Den Agreement (cont).

We reserve the right to accept or deny any application, for any reason (stated or unstated), and you are to hold harmless all ministries and persons involved in the decision. We reserve the right to have anyone immediately removed from the premises for any reason (stated or unstated), and you are to hold harmless all ministries and persons involved in the decision. We cannot accept criminal background history related to sexual offenses, including csc. We reserve the right to deny repeat criminal offenders (regardless of offense, misdemeanor and/or felony), at our sole discretion, and you will hold harmless all ministries and persons involved in the decision.

You will be responsible for your own food and clothing (cooking and cleaning). Laundry facilities must be kept clean and free of clothing. You must not leave your clothes in the machines or in the laundry area. Kitchen and cooking area must be kept clean and free of food, dirty dishes and cooking utensils. Each person will be responsible for himself.

Basic utilities will be the responsibility of the ministry (electric, gas and water). Trash removal will be the responsibility of the persons on the premises, and must be removed on a weekly basis. Build up of trash for more than one week is not allowed. Electric, gas or propane heaters and/or air conditioners are not allowed. Altering the thermostat setting from 68 degrees is prohibited.

You are responsible for your own self-respect, in the manner of actions, words, cleanliness and hygiene. You are responsible for your own respect, in the manner of actions and words, towards your neighborhood and neighbors. We reserve the right to have staff (and/or persons chosen at our discretion) to perform routine day and/or night supervisory status reports. You will be required to allow such status as required by staff to perform these reports, including but not limited to; access to your personal property for search of contraband and/or other illegal, immoral, unethical and/or products and/or activities that may be in violation of agreement, policies, guidelines and rules of the den.

Incidence contingencies. You agree to hold us (all ministries and persons herein) completely harmless for any of the following downfalls including, but not limited to, loss, theft, damage, injury and other incidence (financial or otherwise). You also agree to be held completely liable (financial and/or otherwise) for any personal and/or property damage, theft or financial downfall caused from your actions, or lack thereof.

This is a binding agreement between you and the aforementioned, and it is your responsibility to adhere to these principles, policies, rules and guidelines. These rules may not be all inclusive and you will be informed of any additions or changes to this agreement, and you will receive a written, signed and dated copy upon approval.
